<u>LAS VEGAS EVENTS, INC. – 2025 JUNIOR NATIONAL FINALS RODEO</u> FULL AND UNCONDITIONAL RELEASE FOR MINOR PARTICIPATION IN ARENA EXHIBITIONS

PLEASE READ CAREFULLY BEFORE SIGNING. THIS DOCUMENT HAS LEGAL SIGNIFICANCE.

1. <u>Released Parties Defined</u>: The "Released Parties", as used in this 2025 Junior National Finals Rodeo Event (the "Event") Full and Unconditional Release for Minor Participation in Arena Exhibitions (this "Minor Release"), are Las Vegas Events, Inc., the Las Vegas Convention & Visitors Authority, the Las Vegas Convention Center, any sponsor of the Event, and each of their respective past, present or future attorneys, representatives, partners, directors, officers, members, managers, stockholders, trustees, beneficiaries, agents, employees, contractors, affiliates, predecessors, successors and assigns and all other persons or entities who may ever claim by, through or under such party, and each of them (individually and collectively, the "Released Parties").

2. Express Acknowledgement, Acceptance and Assumption of Risk: I am the parent and/or legal guardian of
(referred to as "Child" or "Minor"). I am fully aware, completely understand and accept
that my Child's participation in the Event arena exhibitions (the "Contest") is dangerous and that the events and activities associated
with, relating to, arising out of and concerning this participation present substantial, serious and real risks of personal injury or death
to my Child and the loss of, damage to or destruction of personal property belonging to me or to my child. I understand and
acknowledge that the Contest may involve physical exertion and contact, and that the Contest may involve falling, bumps, bruises,
cuts, bone fractures, concussions or other bodily injuries, including, but not limited to, being bitten, kicked or trampled by animals
involved in the Contest. I, by my signature below, fully and completely accept and assume these substantial, serious, and real risks,
whether or not apparent, known, unknown, foreseen, unforeseen, present, or contingent, and whether or not caused by the
NEGLIGENCE of any of the Released Parties, or the NEGLIGENCE of any expert, contestant, volunteer or spectator including, but
not limited to, any NEGLIGENCE associated with the design or designing, staging, supervising, maintaining or in any way
presenting, conducting or sponsoring the Event.

- 3. Full and Unconditional Waiver, Release and Indemnification: Regarding Paragraphs 1 and 2 above, which are incorporated into this Paragraph 3, I expressly and completely forever release, waive, relinquish, relieve, discharge, hold harmless and otherwise agree not to sue any of the Released Parties from any and all rights, claims, suits, actions, causes of action, proceedings, judgments, charges, complaints, damages, debts, fees, liabilities, losses, demands, obligations, commitments, promises, acts, agreements, costs and expenses (including, without limitation, attorneys' fees), of whatever kind or nature, known or unknown, contingent or liquidated, past, present or future, whether in law or in equity, including, without limitation, those based on, arising out of, or in connection with my Child's participation in the Contest, including, without limitation, his or her acts or omissions during the Contest, or that could be raised in connection therewith, whether asserted, unasserted, absolute, contingent, known or unknown (collectively, "Claims"). In consideration for permitting my Child's participation in the Contest, I also completely waive, release, discharge and otherwise holds harmless any and all Released Parties from any and all Claims which he/she could assert associated with, relating to, concerning or arising out of the substantial, serious and real risks acknowledged, understood, assumed and expressly accepted in this Minor Release. I hereby agree to indemnify, defend and hold harmless the Released Parties with respect to any Claims brought against, by or on behalf of all or any of the Released Parties in connection with any matter that I release the Released Parties from pursuant to this Minor Release.
- 4. <u>Use of Likeness</u>: In consideration for permitting my Child's participation in the Contest, I grant to the Released Parties the absolute right to take (or commission another to take) and use photographic pictures, film or video tape that feature my Child's likeness, image, appearance, voice, name and/or any material based upon or derived therefrom ("Likeness"). The Released Parties shall have the right to copyright, publish and otherwise use in any lawful manner, whether for artistic, advertising, promotion, or any proper purpose, such pictures, including any work derived therefrom in any medium and manner. I hereby release, waive, relinquish, relieve, discharge, hold harmless and otherwise agree not to sue any of the Released Parties for any Claims for libel, slander, defamation, invasion of right of privacy, publicity or personality, or any other Claim, based upon or relating to the use of my Child's Likeness or the exercise of any of the rights referred to herein.
- 5. Assurances and Representations: I have read this Minor Release and have had an adequate and sufficient opportunity to consider it and to have it explained to me. I fully understand and agree that this Minor Release is to be interpreted and applied in the broadest and most comprehensive manner in favor of the Released Parties. I further understand, acknowledge, and agree that I am knowingly and voluntarily signing this Minor Release with full knowledge and understanding of its contents and meaning and with an intent to be bound thereby, acknowledging that this Minor Release shall be binding on my estate, heirs, administrators, assigns and on my Child. I certify that I am over the age of eighteen and that I am not under the influence of any intoxicants, narcotics, medications, drugs or other substances which would impair my ability to understand this Minor Release. I have full power, authority, capacity and right without limitation to sign, deliver and perform this Minor Release in favor of my Child. I further certify and represent the following:

- g. Without limiting the foregoing, I accept total responsibility for, and agree to pay, any and all medical expenses (including, without limitation, transportation to and from any medical facility) that my Child may incur as a result of participating in the Contest.

Each of the Released Parties reserves the right, in its sole discretion, to disqualify or remove any child from participating in the Contest who requires special care, exhibits inappropriate or abnormal behavior or if any of the above listed representations and warranties are false in any respect.

- 6. <u>Binding Effect:</u> This Minor Release shall be and is binding upon me and my spouse (if any), my Child, his or her parents and each of our legal representatives, heirs, successors and assigns. I agree that this Minor Release is governed by the laws of the State of Nevada. I consent and submit to the exclusive jurisdiction of the state and Federal courts located in Clark County, Nevada with respect to any claim or litigation arising hereunder or any alleged breach of the provisions contained herein, and acknowledge that proper venue in any matter so claimed or litigated shall be in the state and Federal courts located in Clark County, Nevada.
- 7. <u>Severability:</u> The invalidity of any provision of this Minor Release or portion of a provision shall not affect the validity of any other provision of this Minor Release or the remaining portion of the applicable provision unless such invalidity shall frustrate the intent of the parties hereto provided for herein.

BY SIGNING THIS MINOR RELEASE AS THE PARENT(S) OR LEGAL GUARDIAN(S) OF A MINOR PARTICIPANT, I UNDERSTAND THAT I AM WAIVING CERTAIN RIGHTS ON BEHALF OF THE MINOR THAT THE MINOR MAY OTHERWISE HAVE. I AGREE THAT BUT FOR THE FOREGOING, THE MINOR WOULD NOT BE PERMITTED TO PARTICIPATE IN THE CONTEST. I HAVE READ AND VOLUNTARILY SIGNED THIS MINOR RELEASE. I ACCEPT, UNDERSTAND AND AGREE TO BE LEGALLY BOUND BY ITS TERMS.
